LETTER FROM THE CHAIR

Dear Shareholder,

Thank you for your interest in running for a seat on the Kootznoowoo, Inc. Board of Directors as an independent candidate. Kootznoowoo, Inc. (the "Corporation") does not have a board slate. Any shareholder eighteen (18) or older with voting shares in the Corporation may run for a seat on the Board.

The Kootznoowoo, Inc. Bylaws and Code of Conduct and Alaska Administrative Code (AAC 08.305, et seq., Solicitation of Proxies) requires all candidates for the Board of Directors to make certain disclosures about themselves, to communicate that information to shareholders, and to file the disclosures with the State of Alaska, Division of Banking & Securities (the "Division").

You must review and complete the questionnaire in full to qualify as a candidate for the Board of Directors. The Corporation will file your completed questionnaire with the Division of Banking & Securities when the Corporation files its proxy statement so you do not need to send a copy of this questionnaire to the Division.

However, pursuant to 3 AAC 08.312, you are responsible for submitting copies of any materials that you publish on the Internet, including electronic forums such as Facebook, or send to shareholders to support your campaign to the Division of Banking & Securities.
